Our Journey So Far



Over 27 million Pakistanis aged 20 years and above are affected by diabetes. In non-communicable diseases, diabetes was the 4th leading cause of total number of deaths in Pakistan in 2019, while overall it was the 8th leading reason for deaths in the country, according to the USA-based Institute for Health Metrics and Evaluation (IHME).

In World Health rankings, Pakistan falls in the 2nd most dangerous category in terms of the rate of deaths caused by diabetes with 39.62 deaths per 100,000 people. The figures reveal that 1 in every 4 Pakistanis over the age of 20 is stricken with this diabetes and a lot of them are unaware of its symptoms. The situation becomes even more dreadful when it involves alarming figures of poverty and lack of health awareness in the country. As per the latest poverty estimates, 24% of our population is living below the poverty line. The combination of disease and poverty is deadly and it calls for exceptional and immediate actions to protect the distraught people of Pakistan.

Keeping in view the huge prevalence of diabetes in Pakistan, Dr. Asjad Hameed, Chairman of TDC's Board of Directors, made up his mind to put an end to the miseries of diabetic patients by establishing a state-of-the-art hospital in Pakistan to provide complete diabetes care to patients under one roof irrespective of their ability to bear their treatment expenses.

Dr. Asjad, along with his family and friends, opened a small clinic at Phulgran near Murree Expressway Toll Plaza in Islamabad in 2012. Dr. Asjad's untiring efforts started yielding positive results and he was able to create a network of like-minded people who joined hands with him to take up this paramount challenge.

Paving the way for the execution of the hospital building plan, Mr. Tahir Abbasi, CEO and Member of TDC's Board of Directors, generously donated 10 Kanal of land to the hospital in Phulgran, Islamabad, and other well-wishers of TDC donated millions of rupees to cover construction, equipment, and operational costs.

The ground-breaking of Pakistan's first complete diabetes hospital's building took place in 2014 and the hospital

building was inaugurated in 2018. TDC has also opened a centre in Lahore in September 2018, which is delivering out-patient services to diabetes patients, irrespective of their ability to pay. TDC has also launched The Diabetes Centre Clinic at Crescent Arcade, G-8 Markaz, Islamabad in January 2021. G8 clinic is successfully serving patients suffering from diabetes and its related complications. Foreign-qualified doctors and trained staff are providing World-Class diagnostics and treatment facilities to patients. TDC is registered as a non-profit company under section 42 of the Companies Act 2017 of Pakistan. The hospital functions under an autonomous Board of Directors having professionals with the highest moral and professional integrity.

Along with the daycare diabetes clinic, TDC offers specialized diabetes care for diabetic foot, eyes, kidneys (Dialysis), heart, pregnancy, and male health. Other advanced services include clinical laboratory, pharmacy, emergency room, and radiology with modern equipment, health education, cutting-edge technology, and well-trained and experienced human resources.

The hospital has served more than 205,000 patients so far, out of which 64% of patients' treatment was free of cost. The rest of the patients paid for their treatment. All proceeds from the affluent paying patients are spent on the treatment of deserving patients.

TDC's state-of-the-art laboratory, certified by the College of American Pathologists, USA, has performed a record of over 184,000 tests in the year 2019-20. Conducting over 6,000-foot procedures, TDC's advanced Foot Care Clinic has saved more than 2,350 feet from amputation. The hospital has also performed about 24,000 Fundo Scans and around 15,000 Pedo Scans successfully.

A dynamic team of specialist doctors and support staff under able management and dedicated BODs is delivering the best possible services.

TDC is also focusing on educating the masses by regularly setting up free medical camps and awareness sessions at various locations within the country. A highly informative campaign on how to prevent and combat the disease is also being run through social media platforms.

TDC is sharing the burden of government hospitals and creating an important socio-economic impact. This is evident from the rapid growth in the number of new patients seeking appointments every month.

The substantial contributions of local and international philanthropists, charities, and corporate entities in the form of zakat and general donations have so far made TDC's journey a success. TDC is geared up to ensure accurate and powerful diagnostics and treatments for patients to set a new benchmark in the healthcare sector of Pakistan.

TDC has established Tobacco Cessation Clinic in collaboration with WHO and Ministry of Health in May, 2021 and also opening Covid-19 Vaccination and Research Centre.

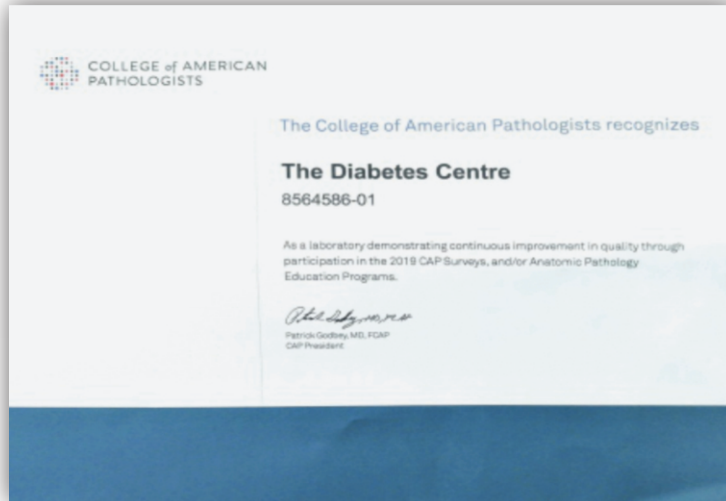


Due to its strong commitment to global best practice, The Diabetes Centre successfully obtained ISO Certification in January 2021 after completing all stages of audit for the certification.

The objective of these audits was to determine TDC's readiness for the certification. A certification body's auditors reviewed the hospital's management system documented information, evaluated the site-specific conditions, and had discussions with management and staff members to ascertain the level of quality standards that are being followed in TDC. After rigorous process of auditing, the auditing body declared TDC ready to obtain ISO certification.

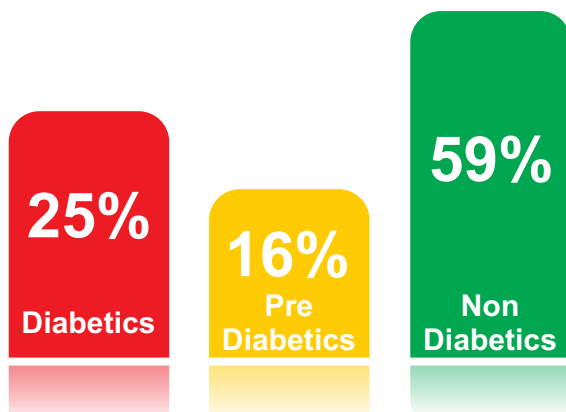

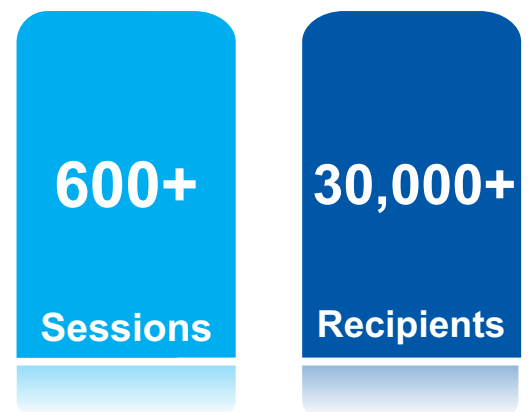

TDC Staff Receiving International Training Aimed at Improved Patient Service



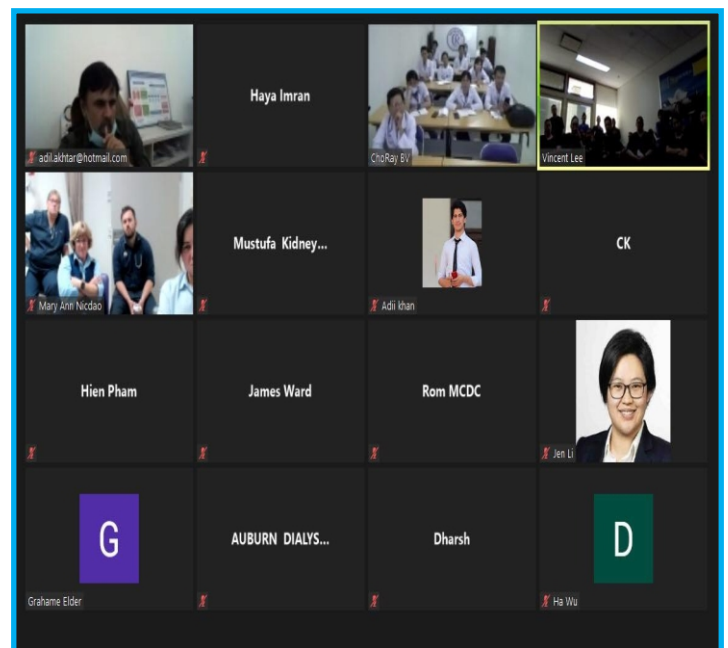
The Diabetes Centre's Management and Board of Directors always keep finding new ways to strengthen TDC team with latest technology, equipment and knowledge through advanced trainings. In this connection, TDC arranged a series of high value training sessions for its staff. A very competent and reputed International Trainer Prof. Dr. Aftab Ahmed delivered the training. Starting from the first week of November 2020, the training sessions continued until February 2021. Prof. Dr. Aftab has been associated with Imperial College London Diabetes Center (ICLDC) as Senior Consultant and Adjunct Professor since 2018. Prior to this, Dr. Aftab was the Clinical Sub-Dean for undergraduate medicine and honorary Senior Lecturer at Liverpool University, U.K., for more than 10 years. He has done Research Doctorate in Medicine from Liverpool University, U.K., with extensive novel publications in the most prestigious and reputable diabetes and endocrine journals around the world with H-index of 16. TDC staff members attended the training

with enthusiasm, as the sessions were very interactive and interesting. Dr. Aftab's method of imparting training was so captivating and engaging that the partakers mostly found themselves glued to their seats until the end of training and question/answer session. "Alongside refreshing our already acquired knowledge, these sessions opened up new avenues for us to learn and implement fresh knowledge and skills for better patient services," Former Head of Medical Departments Dr. Wasiq Zafar Abbasi said after attending first couple of sessions. Haya Imran from TDC's Marketing and Communication Department expressed that, "I am from a non-clinical department, but these sessions provided me a lot of useful information about the basics of healthcare and diabetes and I believe this is very important knowledge to have as a worker in a healthcare setup." Dr. Asjad Hameed, Chairman TDC BOD, Tahir M. Abbasi, CEO and member BOD, and Dr. Nuzhat Hameed, Member BOD and Consultant Diabetologist, took active part in the training sessions.

TDC Organizes International Educational Lecture for Kidney Care Staff

The Diabetes Centre, Pakistan, in collaboration with TDC Australia arranged an advanced level international educational lecture on Hemodialysis for the hospital's Kidney Care Clinic staff. Vincent Lee from Australia delivered the lecture on April 29, 2021, which was attended by a large number of healthcare professionals online from Australia and Pakistan.

The lecture session was focused on imparting the latest knowledge about dialysis, and sharing clinical updates and information about advanced treatment options for kidney patients. During the session, new techniques of better patient care and safety during dialysis were also discussed. The participants said that the lecture was very informative for them. They thanked TDC management for arranging such useful sessions for them. TDC CEO Tahir M Abbasi expressed that the Hospital Management and Board of Directors are determined to providing special training and development opportunities to clinical and nonclinical staff for ensuring improved patient care at TDC.





Purpose:

At the back of Corona virus outbreak and the resultant lockdown in the twin cities, TDC management decided to launch telemedicine services for diabetes patients so that their health and safety are not compromised.

COVID-19/Diabetes Vulnerability Response Plan Partners:

International Committee of the Red Cross (ICRC) joined hands with TDC and they initiated COVID-19/Diabetes Vulnerability Response Plan to serve needy diabetes patients in the difficult time. ICRC partially funded the campaign and TDC offered its expertise and human and other resources for providing telemedicine services to the needy patients.

Scope:

TDC management decided to provide free teleconsultation facility and delivery of medicines to deserving patients at their doorsteps during COVID-19 and lockdown. The plan was to provide teleconsultation to diabetes patients from across Pakistan and free medicines to patients in Islamabad, Rawalpindi division, Lahore, Khyber Pakhtunkhwa and Azad Jammu and Kashmir.

Targeted Beneficiaries:

Beneficiaries are the people suffering from diabetes and its complications including Diabetic Kidney Disease with added problems due to the Coronavirus outbreak and lockdown. They are mainly the registered TDC patients from across the country as well as diabetes patients identified by partners and other reliable sources.

Modes of Medicine Delivery:

TDC implemented direct delivery at doorstep and delivery in the hometown, nearby residence, modes on its own and adopted joint service-delivery arrangements with governmental bodies like with Islamabad Administration,

Rawalpindi District Health Office and Health Services Department, Government of AJK.

Patient Education Materials:

Packs of medicines for diabetes patients also included educational/awareness material on the Coronavirus safety precautions as well as guidelines regarding better management of the disease, diet/nutrition, life style and medication/insulin management.

Project Proceedings:

For this purpose, TDC team gathered the patients' contact numbers and sent them an SMS about our new offering. Also, advertised it on social media and Website. We explained patients about the free telemedicine services and how they can make the best use of the opportunity, particularly during the lockdown.


We developed field teams who went to serve people on ground in all parts of Islamabad, Rawalpindi division, Lahore, KPK and AJK.

As part of the campaign, TDC collaborated with DC Islamabad Office, CEO of Rawalpindi District Health Authority, Health Ministry of AJK and many others to distribute free medicines packs to the needy people suffering from diabetes and its complications during lockdown due to COVID-19 outbreak.

We reached out to over thousands of patients via phone calls to offer free teleconsultation and medicine services. Also, more than 50,000 people have been approached via SMS service and thousands of people are being informed about the services through social media and website posters.

Patient Satisfaction:

Patients, being in trouble due to the Coronavirus and lockdown, were quite relieved upon receiving free medicines. Almost all of them were struggling and worried. They appreciated TDC and ICRC's efforts for them.

TDC conducted an awareness walk and a cycle rally as part of its World Diabetes Day 2020 Awareness Campaign, which focused on appreciable role of nurses in diabetes prevention and effective management. A big number of government officials, government and private sector nurses, doctors, patients and people from various occupations participated in the campaign.

The hospital's awareness campaign included free diabetes screening camps, awareness sessions, and dissemination of educational materials. TDC also offered 14% discount on all TDC services, including lab tests and medicines, to paying patients from the start of November 2020 through November 14, 2020. Deserving patients kept getting free treatment facilities as usual.

The walk was held at TDC on Murree Expressway, while the cycle rally took place on Jinnah Avenue from Centaurus Mall to Faisal Mosque. The main objective of TDC's World Diabetes Day campaign was to raise awareness in communities along with diagnostic and treatment facilities.

TDC, Ministry of Health, WHO making combined efforts against tobacco use

The Diabetes Centre and the Ministry of National Health Services, Regulations & Coordination, Government of Pakistan, (NHSRC) signed a Letter of Intent (LOI) on September 2, 2020, in a ceremony held at the hospital. Under the LOI, the ministry of health will provide progressive support to TDC for already established Tobacco Free Zone by World Health Organization (WHO).

The LOI will serve as a landmark agreement towards achieving sustainable development goals in Pakistan's context by offering tobacco cessation services, creating awareness regarding hazards of tobacco use and its adverse impacts on Nation's economy and environment, observing tobacco control laws at TDC, encouraging research and home to home campaign for a common goal towards a tobacco free next generation and a prosperous, developed country.

Dr. Nausheen Hamid, Parliamentary Secretary for the ministry of NHSRC, was the chief guest who appreciated TDC's efforts for taking practical steps to implement regulations of smoke free zone in full letter and spirit to stop people from indulging in risky behaviors like smoking. She added that the ministry will continue to provide its support to TDC.

Tahir M. 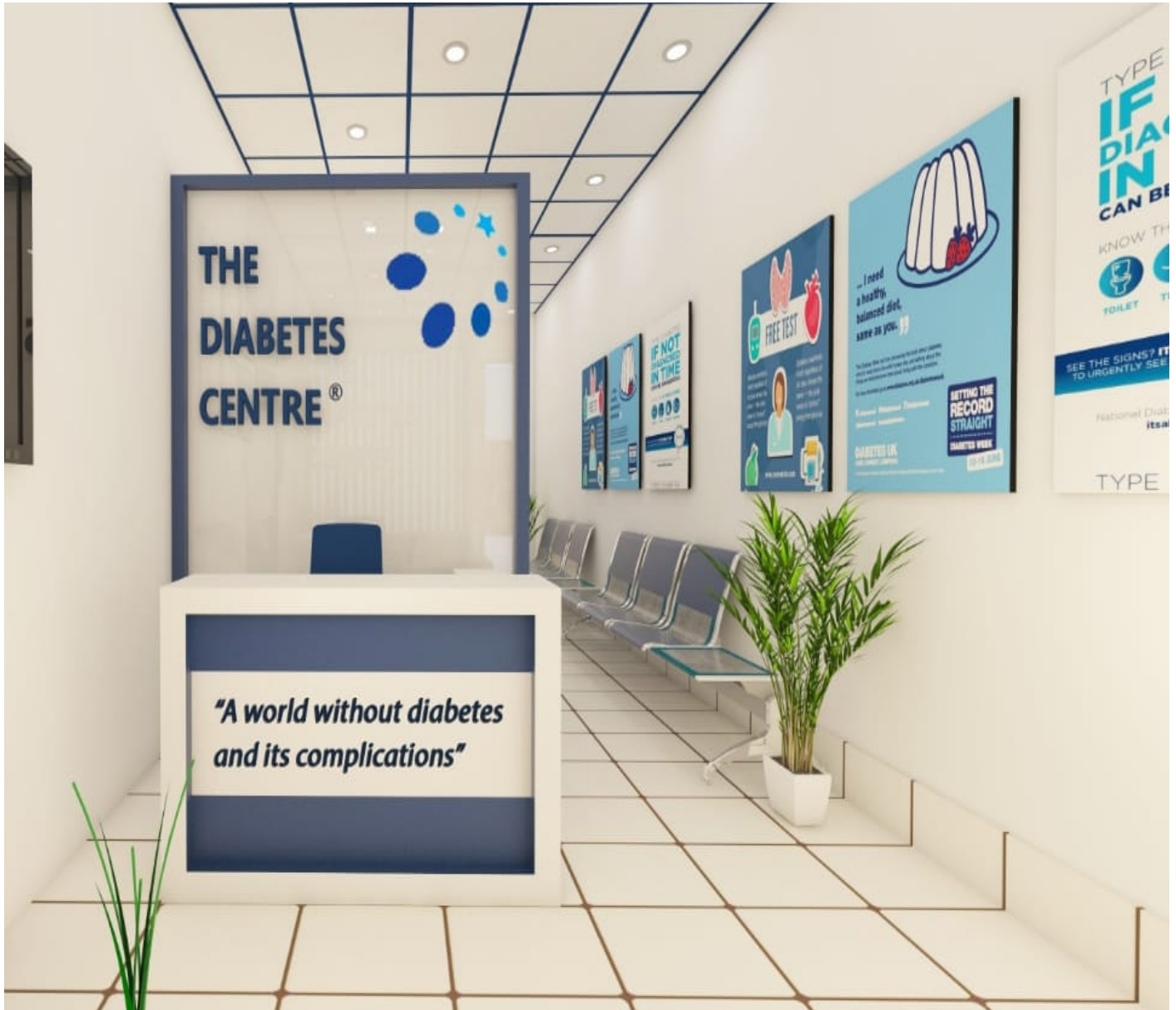

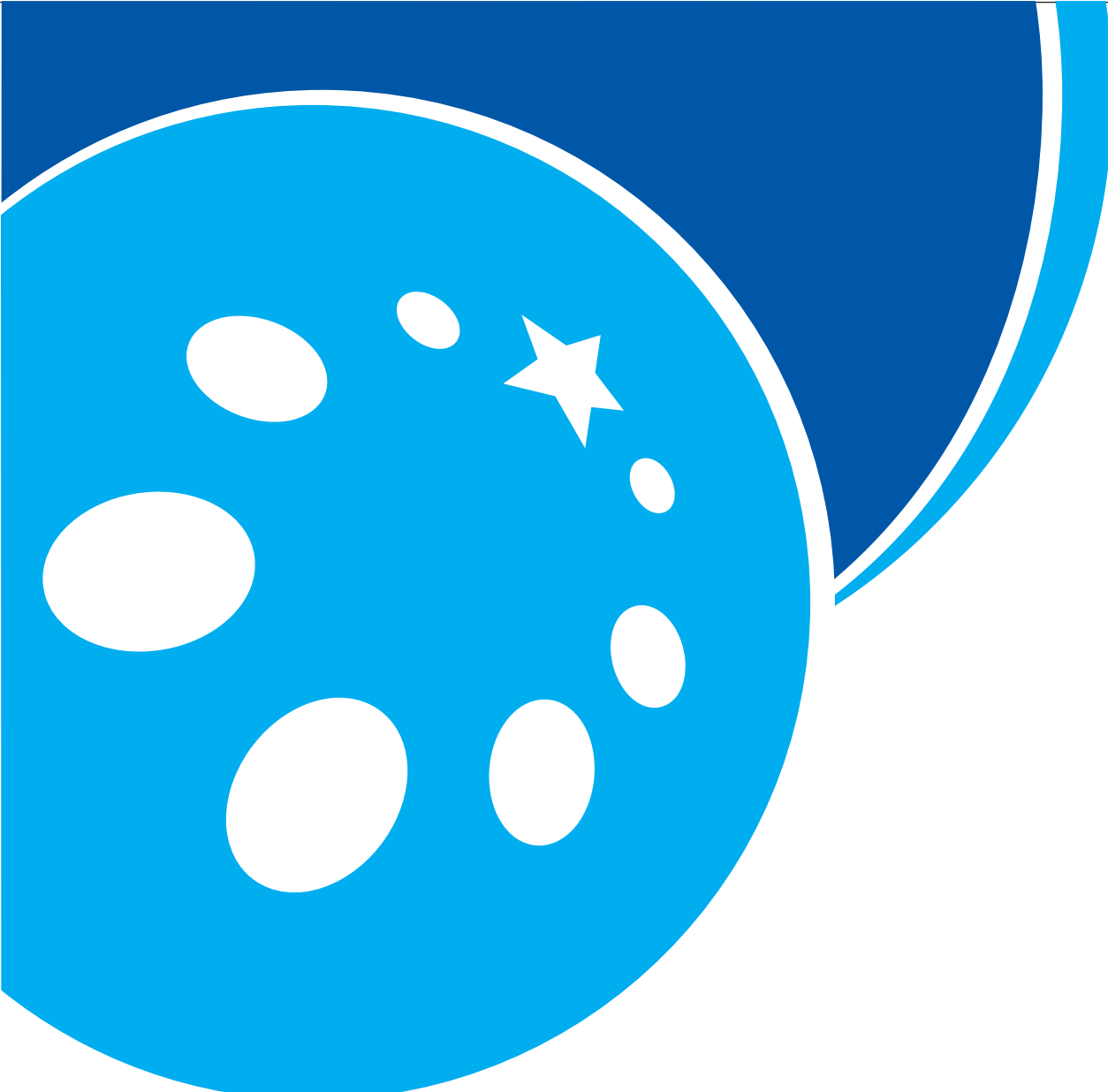
